Points are per CCN member school, not per faculty member.

Points are counted in the 12-month period of January 1-December 31.

New members of the CCN are granted "Level 1" status long enough to allow one "free" March 1 reporting deadline (Level 1 deliverables not required); on next March 1 deadline, the school must deliver "Level 1" points

Level 1 members still must attend CCN meetings hosted in conjunction with Summer/Winter Working Connections to have access to full Working Connections reimbursement amount.

A 30-day appeal period will be granted to CCN member schools, starting when the CTC announces a school's final point total based on material submitted March 1, 2018.

* To earn these points, the supervisor or manager over the usual participating CCN faculty members must join the phone call. Exceptions handled on a case by case basis. Note that a school cannot get points if a faculty member (1 points) and supervisor/administrator (3 points) both attends. A school is awarded the higher points only, 1 or 3. Not 4.

† A CCN member school can only claim one of these elements, either "attend only" or "attend and present." In other words, a CCN school can only get 2 or 5 points related to conferences, not 7. Note also that "present" refers to a 30-minute keynote or a 45-60-minute breakout session. Teaching a Working Connections track counts.
